

Official Rules – PFGBEST® The Future of Trading \$500 Apple® Gift Card Giveaway 2010

These Rules apply to The Future of Trading \$500 Apple® Gift Card Giveaway 2010, sponsored and conducted by PFGBEST, One Peregrine Way, Cedar Falls, IA 50613.

By entering, you agree to be bound by the following rules:

1. All applicants must complete an online Official Entry form to be eligible.
2. The \$500 Apple® Gift Card Giveaway is open to individuals in the general public who are 18 years or older.
3. The Giveaway begins June 1, 2010. Those who are current subscribers to the 30-day trial period for a BEST Test® simulated trading platform or the simulated BESTDirect® Mobile trading platform on that date will be automatically enrolled as entrants.
